

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry/claim instructions are deemed to form part of the Terms and Conditions and by participating all claimants will be deemed to have accepted and be bound by the terms and conditions. Please retain a copy of these Terms and Conditions for your information.

1. **Promoter:** Promoter: Tesco Personal Finance Limited, 2 South Gyle Crescent, Edinburgh, EH12 9FQ.
2. **Who can enter:** This Prize Promotion (**'Promotion'**) is open to all UK residents (England, Scotland, Wales and Northern Ireland) aged 18 or over, except for anyone directly connected with the planning or administration of the Promotion including Tesco employees (directly connected with the planning or administration of the Promotion) , their agencies and their immediate families (spouse, parent, child, sibling, grandparent and/or 'step' family). This Promotion is not open to residents of the Isle of Man.
3. Internet access and purchase is required for entry.
4. Participants are reminded to get the owner's permission before using a computer, device and/or internet access that is not owned or paid for by the participant to enter the Promotion. The Promoter will not be liable for any internet or mobile connection, or other charges incurred in entering the Promotion.
5. Promotion appears cross media with one shared prize pool.
6. **Promotional Period:** There are three individual Promotional Periods (**'Individual Promotional Period'**) each with its own opening date and closing date.

Promotional Period 1: Opens at 00:00 on 1st June 2026 and closes at 23:59 on 30th June 2026.

Promotional Period 2: Opens at 00:00 on 1st July 2026 and closes at 23:59 on 31st July 2026.

Promotional Period 3: Opens at 00:00 on 1st August 2026 and closes at 23:59 on 31st August 2026.

There will be one Prize Draw (**'Prize Draw'**) per Individual Promotional Period.

7. How to enter:

- a. Make a Tesco Travel Money transaction (either purchase or sell currency) at an instore Bureau, online Click and Collect or home delivery at tescotravelmoney.com during the Individual Promotional Period in which you enter.

Retain proof of purchase or proof of transaction.

Promotional Period 1: Purchase must be made between 1st June 2026 and 30th June 2026.

Promotional Period 2: Purchase must be made between 1st July 2026 and 31st July 2026.

Promotional Period 3: Purchase must be made between 1st August 2026 and 31st August 2026.

- b. Go to tescotravelmoney.com/easyjet-prizedraw.
- c. Input your full name, valid email address and mobile phone number.
- d. Only one entry per person per Individual Promotional Period. Entries are not rolled over into a subsequent Individual Promotional Period, and a new purchase or transaction is required for each Individual Promotional Period.
- e. The Promoter reserves the right to determine, in its sole and absolute discretion, whether a participant has already submitted an entry and to disqualify any subsequent entries or prize entitlement.
- f. Bulk entries made from trade, consumer groups or third parties will not be accepted. Incomplete or illegible entries or via third parties or syndicates, entries by macros or other automated means and entries that do not satisfy the requirements of these Terms and Conditions in full will be disqualified. - g. Incomplete, incorrect, illegal, misdirected or late entries will not be accepted. Proof of sending will not be accepted as proof of delivery or receipt. The Promoter takes no responsibility for entries that are delayed, incomplete or lost due to technical reasons or otherwise.

8. Winner selection and verification:

- a. There will be one draw ('Prize Draw') per Individual Promotional Period.
- b. All entries received per Individual Promotional Period will be placed into a random Prize Draw specific to that Individual Promotional Period only, using a random number generator within 28 working days of the Individual Promotional Period closing date.
- c. There is one Winner Per Individual Promotional Period.
- d. The Winner will be the first entry randomly selected from all entries received during the Individual Promotional Period

9. Winner Notification and Claim:

- a. Each Winner will be notified by email by Tesco's third-party agency within 28 working days of the Individual Promotional Period closing date.
- b. Each Winner will have 14 days to claim their prize and provide valid proof of purchase or transaction. Valid proof of purchase or transaction is a Tesco Travel Money transaction (either purchase or sell currency) either at an instore Bureau, Click and Collect or online at at.tescotravelmoney.com made during the same Individual Promotional Period as the Winner's entry.
- c. If a Winner does not respond within 7 days, they will be emailed again and called on the mobile phone number provided at the point of entry and given a further 7 days to respond. If contact cannot be made, or the Prize is not claimed or valid proof of purchase or transaction

is not provided, within 14 days of the initial prize notification date, the Prize will be allocated to a back-up drawn at the same time as the original.

10. Prize and Prize Fulfilment:

- b. Each prize is £4,000 easyJet holidays credit ('**Credit**') & £500 in winner's choice of currency (ex GBP) from those sold by Tesco Travel Money.
- c. Each Winner will receive an easyJet credit code for the value of £4,000 via email within 28 working days of prize claim. The Winner will need to create a free easyJet account to redeem the credit. 12. Data Protection:

- a. As part of the promotion, we collect the following personal data: full name, email address, mobile phone number, and postcode (Winner's only), and surname, and county for the Winners for the purpose of providing a winner list as indicated in clause 13i.
